Marine Mammal Response Program - Through a partnership with CA Academy of Sciences in SF, we are part of the West Coast Marine Mammal Stranding Network that responds to all dead marine mammals on the Mendocino coast. We take level A data, help determine the cause of death, collect and process specimen, and sometimes use the skeletons in our education program. We responded to over 30 animals in 2016, including a 26-ft Orca skeleton which we have cleaned and will articulate in 2017.

Education - We have developed and implemented marine science curriculum for the 1st and 5th grades, addressing the now common core standards, and taught to over 2000 kids. We develop an annual Science and Art Fair, and had many individual and group projects submitted. We have begun a high school internship program, and involved the FB Robotics Club at the high school developing an original piece of technology: NEMO or the Noyo Educational Marine Observatory that allows us to see and hear underwater. We have also developed 2 popular summer camps, field education including a Noyo at Sea program, and held many community education events, including a public lecture series. The outcome is more awareness about ocean conservation and improve ocean literacy in our community.

Crow's Nest Visitor's Center-We opened a new marine science visitor's center on the new Fort Bragg Coastal Trail. We now have 2 sea lion skeletons, a touch tank aquarium, and many public displays on issues affecting our coast. Open 5 days a week, we reach visitors and locals, as well as host class field trips and hold special events. The Crow's Nest is staffed entirely by volunteer docents.
